# Notice To Exhibitors

**Entries close** at 6 p.m., Wednesday, February 22, 2012 after which time entries cannot be accepted, canceled, changed or substituted except as provided for in Chapter 11, Sec. 6 of AKC Dog Show Rules.

**AKC** governs this show. Exhibitors should read and be familiar with the AKC agreement and instructions on reverse side of the official entry form.

**Telegraph, telephone and unsigned entries** cannot be accepted. Entries not on Official AKC Forms or photocopies of forms without the agreement and rules on the reverse side of entry form are not acceptable.

**No Entry** shall be made nor entry shall be accepted which specifies any condition as to its acceptance.

Make checks or money orders payable to the Tidewater Afghan Hound Club. Foreign exhibitors must make fees payable in U.S. funds. Show secretary is not responsible for cash sent through the mail. Mail all entries to Tracee Elwess, Show Secretary. Faxed entries and Paypal to Jerry Bazar, Assistant Show Secretary. All Fees must be received by 6:00pm, Wednesday, February 22, 2012.

The Tidewater Afghan Hound Club may decline an entry, may refuse to receive or may remove any dog due to disease, viciousness or other cause. No claim or recourse shall be brought against the Tidewater Afghan Hound Club, show secretary or any official thereof.

**Entries without fees** will not be accepted. Acknowledgment of entry will be made as soon as practical. If exhibitor does not receive acknowledgment within a reasonable time, the show secretary should be contacted.

**Returned Checks** or post dated checks do not constitute a valid entry fee. The returned check must be made good with cash or money order before dog is permitted in ring. There is a \$50.00 service charge on any returned check.

**Errors on entry forms**. Owners are responsible for errors when filling out entry forms, regardless of who made the error. Entry fees will not be refunded in the event of such errors, nor will cancellation be permitted if entry date has closed. The club and it's show secretary assume no responsibility for the owner/agent entering a dog in a class in which the dog is not eligible to compete or for duplicate entries.

Loss, damage or injury The club, show secretary or officials will not be responsible for the loss or damage to personal property or any dog exhibited, whether the result of accident or other causes. In addition, the club assumes no responsibility for any loss, damage or injury sustained by exhibitor, handler or the general public. It is understood that every dog on the show premises is in the care, custody and control of the owner/agent. The welfare and safety of children is the sole responsibility of parent/guardian and they must exercise control and restraint. Dogs absent, disqualified or excused by veterinarian or judge or barred from competition by the show committee will not receive refund for entry fees. Cancellation of Show due to extreme weather conditions, riots, civil disturbances or any other factors beyond management's control and if it becomes necessary to cancel show or stop competition, no refund of entry fees will be made.

**Judges will not wait for any dog.** Judges will adhere as closely as possible to the judging schedule. Owners or agents are responsible for their dogs being present in designated ring when their class is called for judging.

**Trophies and prizes** will be awarded in the ring at the time of judging. Advise show secretary of any discrepancies. All trophies must be claimed on the day of the show. None will be mailed. If necessary, Show committee has the right to substitute any trophy listed in premium.

**Foreign dogs** are eligible for Puppy and Regular Classes.

# Additional Class Information

**Bred by Exhibitor (BBE) Class Eligibility:** All dogs entered in the Bred-by Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and owner of record of the dog. To Exhibit in this class, Family members must be a breeder and owner of record

**Stud Dog Class**: For Stud Dogs and two or more of their Get. Stud Dogs must be entered in the Stud Dog Class, and must be shown in the ring with their Get. Owner of Stud Dog need not be owner of Get. Entry fee is for Stud Dog and Get as a Unit. Get MUST be entered in Regular Classes.

**Brood Bitch Class:** For Brood Bitches and two or more of their Get. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Get. Owner of the Brood Bitch need not be the owner of the Get. Entry fee is for Brood Bitch and Get as a Unit. Get MUST be entered in Regular Classes.

#### **NON-REGULAR CLASSES:**

**Best Puppy**: Open to the dogs and bitches placing first in the regular puppy classes. No additional entry fee is required.

**Best Bred-By-Exhibitor**: Open to the dog and bitch placing first in the regular Bred-By-Exhibitor classes. No additional entry fee is required.

#### Saturday Only

**Parade of Veterans** (Non-Competitive): Open to all dogs and bitches (Champions and Non-Champions) who, on the day of the show, are 8 years of age or older. Entries in this class may not be entered in any other class at the specialty.

**Parade of Rescue Dogs** (Non-Competitive): Open to all Afghan Hounds, dogs or bitches, rescued and adopted into loving homes. # Directions to the Show Site

**FROM NY, NJ, NEW ENGLAND—Route U.S. 13 via the Chesapeake Bay Bridge Tunnel**: Immediately after passing the southend toll plaza of the Chesapeake Bay Bridge Tunnel stay in the right lane and exit at the FIRST exit which is Rt. 60 East-West (Shore Drive). Turn LEFT (East) at the bottom of the ramp onto Shore Drive. Continue Shore Drive. In approximately 7.5 miles Shore Drive will become Atlantic Avenue. Continue on Atlantic Ave. Hotel is approximately 1.5 miles down Atlantic Ave on LEFT at 57th St.

FROM THE SOUTH—With travel from U.S. 58: Follow signs for Chesapeake / Virginia Beach and take I-64 WEST. Exit onto 264 EAST towards Virginia Beach. Continue 264 until it ends at a traffic light and will become 21st Street. Continue on 21st Street to Pacific Avenue and turn LEFT onto Pacific Ave. Pacific will become Atlantic Ave at approximately 40th Street. Hotel is on the right at 57th Street.

FROM NORFOLK INTERNATIONAL AIRPORT, THE NORTH AND THE WEST—via I-64 East: Continue I-64 into the Norfolk area to 264. Take 264 EAST (flyover) towards Virginia Beach. #### **AGREEMENT**

I (we) acknowledge the "Rules Applying to Registration and Dog Shows" and, if this entry is for an obedience trial, the "Obedience Regulations," have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

#### INSTRUCTIONS

- 1. (Variety) if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color. Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.). Dachshunds (longhaired, smooth, wirehaired). Collies (rough, smooth). Bull Terriers (colored, white). Manchester Terriers (standard, toy) Chihuahuas (smooth coat, long coat). English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles). Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then , in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. # **AKC Code of Sportsmanship**

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundaments of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
